ALD CEO **Tim Albertsen** has over 25 years' experience in the leasing and fleet management industry.

After graduating in Business Administration from University of South Denmark and obtaining a post-graduate degree in the same field from the Copenhagen Business School, he spent several years in management roles at Avis Leasing and Avis Rent a Car. In 1997, he joined Hertz Lease, which was acquired by ALD in 2003.

Tim worked his way steadily up the ranks, serving for a number of years in a series of posts, starting out as Regional Director for ALD in the Nordic & Baltic Countries, then General Manager at Hertz Lease Denmark, Chief Operating Officer and Senior Vice President, before being appointed Deputy Chief Executive Officer, in which role he played a significant part in the company's successful listing on the Euronext Paris stock exchange. He was appointed CEO in 2020.

With a degree in IT and an MBA from Nottingham Trent University, **John Saffrett** joined ALD in 1997, where his first role was in Sales Account Management for the company's subsidiary in the UK, later becoming the IT Director UK from 2002. In 2006, he joined Fimat/Newedge UK, now Societe Generale Prime Services, where he was appointed Europe CIO and Global Head of Corporate IT Services before becoming Programme Director of Fimat/Newedge UK in 2011. He returned to ALD in 2015, initially serving as Chief Administrative Officer and went on to become Chief Operating Officer in 2017. He was appointed as Deputy Chief Executive Officer of ALD in 2019 responsible for managing the company's operations – including client solutions and sales & business development – as well as overseeing the company's IT and digitalization development strategy.

Gilles Momper has been Chief Financial Officer of ALD since 2012. After studying at the Ecole Supérieure de Commerce in Dijon, he began his career at Hertz in 1995 as an internal auditor and later held various roles in the Finance Departments in France and Germany, before being appointed Deputy Accounting Director in 2000. He joined Renault in 2001, as International Financial Controller overseeing profitability for Renault Retail Group and the distribution networks worldwide. Gilles came to ALD Automotive as Deputy Finance Director in 2007. He was appointed Chief Financial Officer in 2011 and joined ALD's Executive Committee. Five years later, he played a key role in ALD's successful listing on the Euronext Paris stock exchange.

Gilles Bellemère has over 20 years' experience in the leasing and fleet management industry. After a degree in Management from Paris Dauphine University and a postgraduate degree in Foreign Trade from Paris Panthéon Sorbonne University, he served in various roles in Société Générale Retail Banking Division from 1987 to 2001. In 2001, he joined ALD France. After five years as Operations Director, he was promoted to Deputy General Manager. He then spent three years as Regional Director in Societe Generale's Retail Banking Division, before returning to ALD in 2017 to become Group Deputy CEO and CEO of ALD France in 2019.

Laurent Saucié has been working for Societe Generale since 1997 in various leadership roles, having begun his career as an Inspector within Societe Generale's Inspection department where he performed audit and advisory work in a range of areas. His first contact with ALD started in 2002 when he headed a full review of ALD to prepare for the acquisition of Hertz Lease.

In 2003, he was appointed to the Societe Generale General Inspection Management Committee. From 2005 until 2011, he joined in ALD in Italy, first as Deputy Managing Director and then, from 2006 as CEO, notably leading the acquisition of LocatRent. In 2011, he was appointed Deputy CEO of Franfinance, Societe Generale's French subsidiary specialized in Equipment and Consumer Finance, before going on to join the bank's Risk Division in 2015, mainly in charge of credit risk management for the Retail Banking, Leasing, Consumer Finance and Insurance Businesses. He notably contributed from 2020 to 2022 to preparations for the merger of the bank's Retail Network and Crédit du Nord in France. He joined once again ALD in March 2022 as ALD's Integration Leader in the context of the acquisition of LeasePlan.

Laurent Saucié is a graduate of CentraleSupélec and holds a Master's degree in Economics.

Jeroen Kruisweg has been with ALD Automotive since 2012, starting as Commercial Director for the Dutch branch. After obtaining a Master's in Financial and Commercial sciences from the Economische Hogeschool Sint-Aloysius and degrees in Corporate Finance and Financial Accounting from EHSAL Management School in Brussels, **Miel Horsten** began his career in 1997 as an Account Manager with Michelin Benelux. In 1999, he went on to join ALD Automotive in Belgium (then Hertz Lease) to manage service operations, eventually becoming International Operations Project Manager in 2001. Miel moved to the central offices in Paris in 2003 and played an instrumental role in the creation of ALD RE, ALD's captive reinsurance company.

In 2007, he relocated to the USA to create a subsidiary for ALD Automotive as Deputy CEO and later CEO, returning to Paris three years later to head up Products and Services for the Group. In 2012, Miel was appointed CEO for ALD Automotive Belgium and combined that role with that of Regional Director Benelux from 2019 until June 2020. 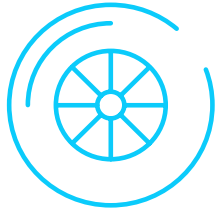

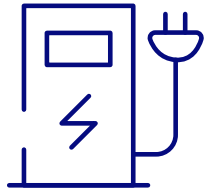
